Previously, David started and led the global 40 Days for Life movement through its first decade, mobilizing 750,000 volunteers in more than 700 cities across all 50 America states and dozens of nations,

whose prayers and efforts have saved 14,643 children's lives, brought 177 workers out of the abortion industry, and closed 96 abortion centers. David has since stepped away from his role as CEO of 40 Days for Life to pray and plan for new ministry projects.

David is an internationally sought-after keynote speaker, and his presentations in more than 550 cities around the world have inspired audiences as large as 70,000 people. David's work has been featured in nearly every major media outlet, including coverage on CNN, ABC, NBC, CBS, Fox News, HBO, hundreds of radio programs, and over 100 newspapers, including The New York Times, The Washington Post, and USA Today.

David has advised many of today's most successful prolife leaders, helping hundreds of organizations increase their life-saving impact. David has been joyfully married to his best friend, Margaret, and they live outside of Washington, DC.



The Daniel Award

The story of Daniel as recorded in the Old Testament brings to life the courageous stand of a man who followed God's directives in his role as the king's counselor and president despite personal consequence. Daniel would not budge in obeying God as he served in the administration of a pagan king – even to the point of death. We need modern day Daniels in the public policy arena now more than ever.

Among the many critical issues of our time protecting life is certainly the most important one. The purpose of the Daniel Award for Excellence in Pro-Life Public Policy is to recognize the extraordinary effort of a public servant in taking a stand for life regardless of the political, personal or professional cost.

Attorney General Curtis Hill



Curtis Hill is the 43rd Attorney General of the state of Indiana. He was formerly the prosecuting attorney for Elkhart County, and he was elected in 2016 with more votes than any other elected official in state history. There is no doubt that Attorney General Hill is the most successful Attorney General to defend pro-life legislation in our state's history. Under his direction, several laws challenged by Planned Parenthood have been

appealed to the Supreme Court with one win and more still pending. AG Hill has authored numerous amicus briefs and signed onto many more. He is known in national pro-life legal circles as one of the "go to" attorneys general in the country.

A native of Elkhart, Hill is the youngest of five children. He credits his parents Curtis Sr., and Eleanor as his inspiration toward public service and leadership. He earned his Bachelor of Science degree in business from Indiana University, Bloomington and received his law degree from IU. It was during law school that he met his wife Teresa. They have five children: Halle, Mallory, Curtis III, Isabella and Abraham.

The Telemachus Award

Telemachus, a fourth century monk who felt God call him to Rome, arrived a day when the gladiators were going to fight. The little monk thought to himself, "Here we are, four centuries after Christ, in a civilized nation, and people are killing one another for the entertainment of the crowd. This isn't Christian!"

Telemachus walked out to the center of the amphitheater, and stood between two large gladiators. Putting his hands up, he meekly cried out, "In the name of Christ, stop!" One of the gladiators slapped Telemachus in the stomach with his sword. Telemachus got up and repeated his plea. This time the crowd chanted "Run him through!" One of the gladiators took his sword and ran it through Telemachus' stomach. He fell into the dust and the sand turned red as blood ran out of him. One last time, Telemachus weakly cried out, "In the name of Christ, stop." He died on the amphitheater floor. History records that this was the last gladiatorial contest in the Roman Empire.
