March 19	Women's Pavilion (owned and operated by Ulrich Klopfer) raided by Special Victims Unit - South Bend.

June 16	Lake County sets trial date of Jan. 26, 2015 on charges Klopfer failed to report to Indiana officials within three days that he performed an abortion on a 13-year-old girl.
June 27	Indiana law requiring abortionists to have admitting privileges at a local hospital or have a formal agreement with a doctor who does, will go into effect on July 1.

	Indiana Department of Health informs abortionist Klopfer that he can no longer perform abortions at his Gary, IN abortion facility, Friendly Family Planning, because he has not complied with this law.
September 17	The office of Indiana Attorney General Greg Zoeller filed administrative licensing complaint with the Indiana Medical Licensing Board after completing their investigation. Zoeller said, "The pending criminal charges brought by county prosecutors along with the sheer volume of unexplained violations by this license holder merits review by the Medical Licensing Board to determine whether disciplinary action is warranted for the noncompliance." The Attorney General's office explained that while Klopfer filed "pregnancy-termination reports" with ISDH [Indiana State Department of Health] on 1,818 abortions he performed between July 2012 and November 2013, "all 1,818 reports were incomplete and incorrect in some way," according to the complaint. "Each report contained on average four omissions or errors involving medical and statistical information that must be reported to ISDH for statistical purposes."
October	Medical Licensing Board hearing continued to January 21&22, 2015
December 1	Klopfer enters pre-trial diversion program for St. Joe County charge that he did not report an abortion performed on a 13 year old girl as required by law. He is ordered to pay \$330 in fees and other costs, not commit any criminal offense during the year-long agreement, perform 24 hours of community service, report to the prosecutor's office when requested and notify the prosecutor if he moves.
January 2015	Indiana State Department of Health (ISDH) files complaint to close Women's Pavilion abortion facility in South Bend.
June 2015	ISDH files second complaint to not renew license.
June 2015	Klopfer surrenders Friendly Family Planning Abortion Clinic facility license located in Gary.
June 2015	Klopfer appeals ISDH facility license revocation for Women's Pavilion abortion facility in South Bend.
November 4, 2015	Klopfer drops facility license appeal.
November 6, 2015	Klopfer performs last abortion in Indiana at the Women's Pavilion.
August 26, 2016	After several rescheduled hearing, the Indiana Medical Licensing Board indefinitely suspends Abortionist Klopfer's license to practice medicine in Indiana.
